

PADDLE SA PRESIDENT - JIM MURPHY

The 2021/22 year has been a very busy one as we leave Covid behind and look forward to a normal year with many opportunities to grow our sport.

A sad moment for us all was the passing of board member Eddie Andriessen late last year. Eddie's enthusiasm and ongoing great work on the Paddling Trails SA initiative in partnership with Meredith will be greatly missed.

The realignment of our Strategic Plan to Paddle Australia's was completed but we soon realised we need to step back and reassess what we want is achievable.

Once again the disciplines have done a great job in offering competitions, and both Sprint and Polo held successful National Championships in Adelaide. This led to a number of athletes selected to National Teams. We thank them for their efforts and congratulate them on representing their country with dignity.

I would like to take this opportunity to thank Laurence Fletcher our SASI head coach for his work in SA, and congratulate him on his selection to the National Coaching Team. We are now able to welcome David Smith as our new Head Coach and look forward to his influence in our state.

The Education committee continues to set the standard for instructors in Australia and is also an important income stream for the sport. We are looking at where we go from here with education and will employ a community development officer as soon as is practical.

Para Canoeing led by George Hucks has continued Saturday training days and has started a mid week session. We are always looking for paddling support for this activity and welcome any interest from people willing to help.

Last year the Paddling Trails SA website proved to be a great success and people continue to use the site for their paddling activities. This year watch out for the She Paddles initiative. These initiatives come under the Recreation Committee banner, and this group, led by Meredith Blesing and Lawrie Shem were responsible for a stand at the Caravan and Camping Show. This was a great opportunity to showcase all aspects of our operations.

A partnership with SA Water saw Paddle SA appointed Event Manager for the official opening of the Happy Valley reservoir in December, and also run some very successful 'Come and Trys' in June at that site. We hope to build on this relationship in 2022/23.

Our clubs are Paddle SA and they are all struggling along in a new world post Covid that has seen volunteering fall away, and many people looking at different types of paddle sports. Congratulations to all the committees for fighting the good fight. Once again you can see we have continued to manage our finances and we still have a good reserve to ensure we can keep stay afloat in adverse times.

For many years we have worked with the City of Charles Sturt to improve our facilities and this year the Council sourced funding from the Federal Government. This led to a lot of meetings /negotiations and we settled on the current design for the Aquatic Reserve facilities redevelopment. The amount of work to clean all of the gear from this was enormous and the container compound and Scout Shed plus storage at Mr Doors is full to capacity. Work is proceeding at a good rate and we expect to move back in late January. West Lakes Paddle Sports are still functioning along with Dragon Boats SA and Education is still able to access equipment.

At this stage I would like to thank a number of people. This is always fraught with danger in that you often miss out someone so let me say at the outset a big thank you to all members of the SA paddling community as you all contribute to our activities.

1.The Paddle SA Board -- James Tucker, Mark Bulmer, Meredith Blesing, along with David Heard, were a small group of dedicated people for the whole year. At various times we had people show interest but fall away often due to Covid or family considerations. It looks like that is about to change for the better this year.

2. Lawrie Shem has worked as a volunteer on the Trails project, manager of the All Access ramp project in the Riverland, opening of Reservoirs, coordinating the Caravan and Camping show and various other activities.

3. Luke Haniford for his coaching at TID and Development level and great success with O/S athletes. Luke is always available as a sounding board for projects with fresh ideas.

4. Our commercial sponsors of Ian Hume at Roof Rack City and Matt Duggin at Mr Doors continue to dig deep and support us in a variety of ways.

5.The Office for Recreation, Sport and Racing, and SASI have continued their vital assistance with critical funding, advice and support.

6. At a National level Phil Jones and his team at Paddle Australia have worked hard to keep our activity relevant and aligned with best practise policies.

7. My personal thanks go to our Executive Officer David Heard. He is always across our requirements with the National body, is up with the reporting to funding bodies and continues to assist with our funding needs. David is always available to discuss issues and hopefully assist finding solutions. Shirley Higgins does a great job as 'the keeper of the money' and does so in a pleasant and efficient manner. The state of our finances is a good indicator of their work.

The past year has been very good considering the general economic and social situations and we look forward to a bright future. We plan to develop the education and recreation components of our activities and there is a great new initiatives such as She Paddles to be introduced shortly. We look forward to increasing the activity base of all our disciplines.

PADDLE SA EXECUTIVE OFFICER - DAVID HEARD

EDUCATION AND SAFETY TECHNICAL COMMITTEE REPORT

The group continued to be active throughout 2021/2022. The EO has taken on more of a role in organising staffing for programs with support from the group and the group would like to thank him for this with ESTC members time poor at present.

4 meetings were held throughout the year and the biggest event on the calendar remains the Assessment weekend in February with 24 people attending the weekend including 2 trainee assessors, one re-registration from many years ago and 16 candidates.

On-demand courses and assessments continue with the result that Paddle SA awarded 60 qualifications in total with 36 who identified as female and 24 that identified as male – a good result comparatively with other states per capita. This included 30 Instructors, 14 Guides and 16 Supervisors.

UniSA remains one of the largest feeder organisations for qualifications and the new Paddle Australia – Australian Tertiary Outdoor Education Network MOU should yield even greater numbers from both UniSA and now Flinders University programs that are both in growth phases.

As ever, there have been many active assessors who have worked hard to provide access to quality instruction and assessment including Wayne Hooper, Libby Robertson, Jim Townsend, Peter Carter, Phil Doddridge, Phil Noble, Micha Jensen, Lawrie Shem, Nick Glover, Leigh Richardson, Joss Rankin, Simon Mulvihill and Malcolm Hamilton. Anna Jones and Geoff McCaul are two younger assessors that add energy and fresh ideas to the group.

Bernard Goble and Phil Doddridge have been active with Adelaide Canoe Club and provide excellent support for members there. Anne and Simon Langsford also provide excellent support for school and other programs that provide opportunities for new instructors to be mentored by them.

Peter Carter continues to provide his wisdom and is always on hand to provide much appreciated support and a critical eye. Special mention to Stephen Carter who has been active in the Northern Region and Wayne and Libby who continue to be prepared to provide on demand courses and assessments.

The aquatic centres with Leigh Richardson at West Lakes and Mary-Ann Stacey at Port Noarlunga among others remain active in supporting training and assessment with increased demand for the higher-level Instructor qualification. James Fishers now has a fulltime role at TAFE and no doubt will continue to support high quality graduates from this institution.

The group will continue to target potential future assessors to help guide the group and conduct assessments in the future with some exciting instructors coming through that show great potential for mentoring others toward higher order practice. No doubt there are others that are active in training, assessing and mentoring that I have not listed here.

EDUCATION AND SAFETY TECHNICAL COMMITTEE REPORT CONT.

Overall, a successful season although availability of assessors for scheduled programs is at times a challenge and mentoring new assessors will be important to maintain viability and energy within the group.

For the future the group would like the role of a development officer to be reconsidered, focussing on school and community programs that provide a service and income stream as well as supporting the activities of the ESTC to capitalize on the new facilities at West Lakes. This role would provide much appreciated support to the EO and ESTC.

FLATWATER TECHNICAL COMMITTEE REPORT

PSA FLATWATER TECHNICAL COMMITTEE CHAIR - MARK BULMER

The last two years have been a very challenging time for all sports, but it was pleasing to see that the majority of National and Canoe Sprint and Marathon events continued through this period.

This has been in part due to the fact that canoeing is an outdoor activity, but it's been the collective commitment and perseverance of our paddling community that the pandemic caused minimal disruption to our sport.

For me the best example of this was the 2022 National Canoe Sprint Championships, which were originally scheduled to be in Perth in March 2022, but rescheduled to Penrith due to ongoing pandemic restrictions in Western Australia.

Then, in February the weather intervened again, as it had done in 2021, causing floods and water quality issues at the Sydney International Regatta Centre and, for the second year in a row, a decision was made to hold the Nationals in Adelaide in May.

The efforts of many, including a large number of our local members and supporters, made the Nationals a great success. Of particular note was the many juniors who competed. Many thought that we would be a risk of losing a generation of athletes, but we held the competition, and they came in large numbers.

Also, the 76 volunteers and officials who assisted with the running of the event, was very pleasing to see. Certainly, the commitment shown by the SA paddling community to assist with the event was incredible.

We are now in a position to get back to normal and grow our sport further. It's important to note that success only comes from the coordinated and committed efforts of the technical committee, clubs, volunteers, coaches, athletes and supporters, and I thank everyone for their contributions over the past 12 months and look forward to working with you all for the next year.

We are also very grateful for the support from ORSR and SASI, and appreciate the good working relationship we have with them.

Finally, I'd like to acknowledge and congratulate all of our state members who have recently re[presented Australia in overseas competitions, including the Junior/U23 Canoe Sprint World Championships in Hungary, the Asia Pacific Sprint Cup in Japan and the Canoe Marathon World Championships in Portugal. It's great to see international competition up and running again.

All the best for the 2022/23 season.

CANOE POLO TECHNICAL COMMITTEE REPORT

PSA POLO CHAIRPERSON - NOEL HOLMES

The Committee

2021 and 2022 Polo activity in SA was overseen by several Committee longstanding members who met several times during this year. Anthea Courtney, Rob Watson, Steve Wild, Leigh Richardson, Will Poley, Peter Duong (retiring as Communications Officer after a decade) and Scott Poley have more lately been abetted by Dermot Cussen and Julie Moroney, with energy and insight of young adult players Alex Trewartha and Will Polley (now resigned to contribute to Adelaide Canoe Club) guiding competition, training and development.

A player forum was held in March 2022 to gather player comments and ideas; and PSA Polo will: seek to benefit from some new player communication apps; diverge from Polo Tech Committee competitions to club-based run events; with our committee keeping state development and national activity responsibilities. The change is judged desirable, practical and successful so far, with similar patterns now arranged for 2022/23. Reshaping of the PSAPolo role is underway.

Activity & Accomplishments 2020/2022

Planning for South Australia to run the 2020 Australian Championships, put aside due to Covid 19, aided us running a 2022 National Championships at West Lakes.

- SA players' labour and flexibility to form draft teams to support interstate players saw SA, NSW, Qld and ACT players gain a sense of strong accomplishment and comradery.
- Paddle SA staff and board gave highly valued, crucial, administration, equipment and National liaison help: we felt supported at that difficult time.

Scott Polley, with UNISA student physical/sports trainers, ran a development camp in January 2022, supporting young player 'elite' development for SA and Vic. Sessions were led by Will and Leigh, aided by Anne, Simon and Alan Toohey, Scott Polley, Steph Sullivan.

Steph, Anne, Simon, Leigh and Will have supported young canoeists and polo players locally, regionally and nationally, in a number of PSA and NDCC programs, including Trinity College.

In 2021, Northern Districts Canoe Club ran:

- A series of summer monthly one-day events, drawing back past-elite and local-season players
- their 20th(?) Australia Day National Summer Series Competition event.

In 2021/2, Adelaide Canoe Club ran:

- The November weekend of instruction and games at Tintinara, strongly supported by Faith Coleman, and the local Action Club, attended by around 30 Adelaide paddlers, with several local families' children gaining instruction.
- The outdoor Summer Seasons at Payneham, attended by some 20 to 30 [L1] players, a few new and some returning but most being core-group players.

CANOE POLO TECHNICAL COMMITTEE REPORT CONT.

• Indoor Winter and Spring Competitions at Westminster School pool, with variously 15 -25 players. Will, Alex and Steve as ACC members ensured event success, backed by Juliette Cools, with an additional ACC focus on young women's development.

Management and storage of gear (PSA owned) has been generously handled by Steve Wild.

A similar series of national and local events is scheduled for 20223/3.

Polo Issues

- With longstanding PSA Polo office-bearers seeking more personal time, new members are wanted.
- Elite player pathways need ongoing development and a youth/parent influx. School programs need school pools, with few available in Adelaide.
- National travel is expensive in time and money, requiring rationalisations.
- Elite players are often too busy to mentor the 'up and coming' apt solutions are needed.
- Casualisation of teams requires visible, fixed, economic venues, which but they are few, with full size fields and expensive. Payneham pool is unavailable during 2023 reconstructions. Smaller pools are in use, with Mawson Lakes occasionally available for full-size fields.
- SA Polo isremains Adelaide based regional development needs funds and regional and Adelaide volunteer commitment.
- Sponsorship is not effectively available.

<u>Financials</u>

The financial position of PSA Polo is represented on the PSA sheets. The committee remains solvent, assets predicted to remain largely 'as is' till run down by equipment renewal.

Further committee induction to Paddle Aus and PSA financial reporting procedures is required, to report transparently and efficiently.

The present available funds were gained through local event takings largely supplemented by a surplus gained in running National competitions in 2019 and 2022, and an April PSA \$1000 input.

We expect a new patterns of income will need to be developed now that regular competition income will largely go to the clubs running programs.

Rationale for PSA Polo owning and managing competition equipment is an agenda item for 2022/3.

CANOE POLO TECHNICAL COMMITTEE REPORT CONT.

Conclusion

Polo remains viable at its current level in Adelaide, due to heavy commitment of several people, but there is a need for concerted development if we are to be a viable ongoing national sector.

Continuing but growing vitality at club level potentially will support growth.

Committed regular involvement from potential committee members could take Polo into a stronger future.

CANOE SPRINT TALENT PATHWAY REPORT

The delivery of the Canoe Sprint Talent Pathway can be broken into 3 main areas utilising funding from the Office for Sport Recreation and Racing, and Paddle Australia.

- Kayak Talent Squad/ State Development Program
 Talent ID/ Talent Search/ Talent Transfer
- Club Development Programs Kayak
- Club Development Program Canoe

In 2021-2022 the Talent Pathway worked with 45 regular participants plus many more athletes from short term programs (Paddling Technical Clinic, Henley High School Specialist Sport Program, Portside Christian College, Talent Search). There were 12 coaches that mostly worked across the regular club and PSA based programs.

Kayak Talent Squad/State Development Program

The Kayak Talent Squad program was coached and coordinated by Luke Haniford for most of the year. This included planning, communicating, and running 5-8 on-water training sessions per week from the SASI Canoe Sprint Facility at West Lakes. This coach was required to backfill the SASI coaching role for 5-6 months, so Jayden Ellis and Bernie Wallace were brought in to cover the coaching of the on-water program.

There was a Strength and Conditioning program organised for 2 sessions per week through the strength building phases of the yearly plan which equated to roughly 7-8 months of the year. This program was conducted at SASI by SASI recommended S&C casual staff.

A total of 22 athletes were involved in regular training with the Talent Squad throughout the year. All Kayak Talent Squad athletes competed across local and State Championship regattas with 16 out of 22 athletes also competing in the National Championships. The 6 who did not race at Nationals were very new to the sport and had a focus on competing at the 2023 National Championships. 12 past* and current state pathway athletes were selected in National Teams and Squads.

Club Development Programs - Kayak

3 clubs received support through the Paddle SA Canoe Sprint pathway funding. This assisted Holdfast Bay Paddle Sports, Onkaparinga Canoe Club, and West Lakes Paddle Sports to run development programs for junior athletes. More details will be available from each club report.

<u> Club Development Program – Canoe</u>

West Lakes Paddle Sports (WLPS) delivered a Canoe Specific program to 7 athletes across the year. This included technical on-water coaching 3-5 sessions per week, 1-2 basic S&C/ body coordination/ movement pattern sessions per week, and coaching at local, state and national competitions.

Conclusion

Overall, it has been a very successful year with the Canoe Sprint Talent Pathway programs and activities despite losing the SASI coach to National Team opportunities leaving a solid hole to fill. I want to thank all the coaches and athletes that kept on doing great work even when we were undermanned. We are now in a great position to continue building the pathway activities and programs to increase both the quality and quantity of paddlers in SA.

ADELIADE CANOE CLUB PRESIDENT - MARK LORAM

The past 12 months has absolutely flown by for the Adelaide Canoe Club (ACC), with an even busier paddling calendar this year, all this despite the cold snaps and SW winds we have been experiencing.

Our goal through the year has been to provide an eventful and broad paddling calendar for club members, while also aiming at attracting new members. Membership remains healthy, currently sitting at 126 and will hopefully increase over the summer months.

We have a steadily growing number of Sunday paddlers turning out for Matt Condon's Semaphore South Peer paddles, and the core of experienced paddlers continues to grow. Several recent members have been approved for sea paddling events and are now regularly joining the group.

Our new website is proving particularly helpful in attracting new members and the Committee is continuing to add information such as the recent Testimonials from several members. Thankyou to Matt Duggin as he continues to store the majority of the club's equipment for us.Nick Salvemini for sourcing and installing the current water tank and water supply within the compound. We are looking forward to moving in to our renovated facility early in the new year.

Throughout the year, we ran a number of Holiday Programs (October and January)– these proved to be very successful and have resulted in a new Junior Paddle group being established. This group is overseen by Amy Barnett and the sessions coached and run by the emerging coaches amongst our junior members.

Our Junior Coacher also completed their basic skills flat water certificates with Simon and Anne Langford. We are looking forward to having school holiday programs happening throughout the coming year and giving our junior instructors and paddlers opportunities to continue to develop.

As you can see from the financial report, we have ended the year with a surplus of \$15000. Some of this can be attributed to a very successful year of Fundraising – the Wine Drive in July raised over \$3500. Whilst Bunning's BBQs proved once again to be another good source of fundraising.

In October 12 adventurous paddlers participated in Murph's Mighty Murray Paddle -

It was an opportunity for a social event involving camping and paddling that took paddlers away from the familiar Westlakes environment to the enticing River Murray. The event started on Wednesday afternoon and ended on Saturday afternoon, with camping at Kingston on Murray and Morgan Caravan Parks as we made our way down the river.

By the end of the weekend, we had between us covered over 390km. Some individuals having covered 158km!

On the 18th/19th December a smaller group returned to continue the journey from Swan Reach onwards. Unfortunately the weather was against us this time and we had to call it a day at Mannum.

In December, a group of us went to the Warren Reservoir for a family fun day / Paddle SA organized Come and Try event.

WEST LAKES PADDLE SPORTS REPORT CONT.

This year, the Club was responsible for providing and financing its own coaching program. We received 2 grants of \$3000 each for providing a junior Canoe and kayak development program.

We had a very successful year, getting a number of capable and very skilled coaches to maintain a training program that took the athletes confidently through the Sprint season to Nationals. The Squad consisted of 18 athletes, consisting of adult and Junior members.

Notes to Financial Statement at 30 June 2022

- Note 1. Summary of significant accounting policies.
 - 1. The financial report is a special purpose financial report prepared to satisfy the financial reporting requirements of the Associations Incorporations Act 1985.
 - 2. The financial report has been prepared on a cash (not accruals) basis.
 - 3. The following material accounting policies, which are consistent with the previous period, unless otherwise stated, have been adopted in the preparation of the financial report.
 - 4. Receivables (money owed to the Club by a member or others) is an accrual item and causes distortions to financial reports that are prepared on a cash basis. The Committee has determined not to include receivables in the Balance Sheet unless material.
 - 5. Income Tax: As the Club is a not-for-profit organisation established for the advancement of sporting activities, it is an exempt entity and therefore not liable for payment of income tax in accordance with Section 50-1 of the Income Tax Assessment Act (1977).
 - 6.Assets under \$1,000 are expended whilst those over this amount are depreciated to provide for replacement in the future.
- Note 2. Other Grant Income received;
 - 1. Paddle Australia: Contribution towards Coaching role: \$36,000.
 - 2. Office of Recreation, Sport and Racing SASI.: \$21,450.
 - 3. Department for Environment and Water \$30,000 All Access Ramp Project
- Note 3. Other income includes Dragonboat SA, EFM and West Lakes Paddle Sports rentals for nine months of the year.
- Note 4. State Grant Income includes;
 - ORSR Sustainability \$30,000, COVID Recovery Stimulus \$12,810 and SASI Special Initiative Grants \$53,000.
- Note 5. Contractors: PSA engages with various specialists to provide a range of coaching and educational activities on behalf of the Association.
- Note 6. Corporate Admin Fees were previously represented by Affiliation Fees paid to Paddle Australia. However, these fees are now collected up front by Paddle Australia at time of membership subscription sign ups and renewals
- Note 7. Other Expenses primarily represents honorarium payments for services rendered and reimbursements for meeting expenses.
- Note 8. Salaries & Wages Include;

Independent Audit Report For the Year ended 30th June 2022

I report to the members of Paddle SA Incorporated (PSA) that I have examined the books and records of the Association for the year ended 30th June 2022, as presented to me which include the following:

- (a) Statement of Receipts & Payments for the year ended 30th June 2022
- (b) Balance Sheet as at 30th June 2022,
- (c) Access to Xero Accounting system,
- (d) Statements by Committee Members.

The Finance Committee of PSA is responsible for the preparation and fair presentation of the financial report. The information and statements provided to me are in accordance with the Associations' constitution.

It is the Finance Committees responsibility to establish appropriate internal controls to allow the financial statements to be produced that are free from misstatements, whether due to fraud or error, selecting and maintaining appropriate accounting policies, and making accounting estimate that are reasonable in the circumstances.

The procedures performed in the review are substantially less than those performed in an audit conducted in accordance with Australian Accounting Standards. Accordingly, I do not express a full audit opinion on these financial statements.

However, I have complied with established standards and performed the audit to obtain reasonable assurance that (a) the transactions recorded in the bank statements have been recorded in the Statement of Receipts and Payments and the Balance Sheet and (b) whether the financial report is free from material misstatement. No opinion is expressed as to whether the accounting policies used are appropriate to meet the needs of the members.

A review of the financial statements is a limited assurance engagement, which consists of making enquiries primarily of persons responsible for financial and accounting matters and evaluating the evidence obtained.

The financial report has been prepared for distribution to members to fulfil the Committee's financial reporting obligations under the Associations' constitution. I disclaim any assumption of responsibility for any reliance on this report, or on the financial report, to any person other than the members, or for any purpose other than that for which it was prepared.

It has been advised that the Finance Committee believe it is impractical to establish further internal controls over the collection of membership fees (EZIDEBIT) and other fund-raising activities prior to entry into its financial records. Albeit, that at least two members must sign off on any cash payments made from the cash proceeds of any activity. Accordingly, as the evidence available to me regarding this source is limited, my audit processes with respect to membership and other fund arising activities had to be restricted to the amounts recorded in the financial records. I am therefore unable to express an opinion whether membership and other fund-raising activities of the Association obtained are complete.

Independent Audit Report cont. For the Year ended 30th June 2022

There is a further qualification with respect to Salaries, wages and associated costs. I was unable to validate that the salaries and wages paid were in accordance with any award or authentication from the board or whether the superannuation, taxation deducted or workers compensation was in accordance with current legislation. This disclaimer withstanding, the records demonstrate consistent fortnightly payment to various staff with corresponding entries to superannuation and tax payable. There are quarterly returns to the Australian Taxation Office based on the Xero Accounting system and the amounts processed into the superannuation and taxation payable accounts.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion in relation to the Financial Report as at 30th June 2022.

Subject to the above qualification, I am of the opinion that the financial report of the Paddle SA Incorporated is consistent with the accounting policies noted, materially represents a true and fair view of the results of and the position of the Association for the year ended 30th June 2022.
